**ADULTS' PERSONAL SOCIAL SERVICES: DISTRIBUTION OF SCE(R)
SINGLE CAPITAL POT AND MENTAL HEALTH ELEMENTS IN 2007-08**

ISSUE

1. This letter sets out local authority allocations in respect of 2007-08 provisionally issued via LASSL (2005)7. Details of the allocations, by local authority, are provided in Annex A to this circular.

ACTION

2. This letter is for information only.

FUNDING AVAILABLE FOR THE SINGLE CAPITAL POT

3. In 2007-08, the Department of Health will make available a total of £27.727 million for the single capital pot element of SCE(R). Total capital funding in this category is distributed using a formula unique to each Department. Annex A provides details of the distribution to each local authority according to the DH formula set out in paragraph 5 below.

DISTRIBUTION FORMULA FOR DH SCE(R) SINGLE CAPITAL POT

4. As in previous years, the distribution has been calculated according to a distribution formula which comprises the following factors:

i) Each authority's population (year 2005 estimated data) weighted by age in the ratio of:

18-74 years	x 1
75 years and over	x 2

ii) 70% of the weighted population is then adjusted to take account of variations in building costs in different parts of the country. ODPM's current Tender Price Index for Social Housing is used for this purpose (Annex B refers).

DISTRIBUTION OF SCE(R) FOR MENTAL HEALTH

5. A total of £22.6 million in 2007-08 will be made available by DH for the mental health element of SCE(R). This distribution is ring fenced.

6. The £22.6 million will be distributed on the basis of each council's proportional share of the younger adults' RNF, with a 2.7% floor applied to mitigate the impact of the step-change in funding caused by the introduction of a new PSS formula for younger adults in 2006-07. Annex C refers.

CANCELLATION OF CIRCULARS
