Notes:

1. FTRS: Full Time Reserve Service. FTRS strength figures include Full Commitment (FC), Home Commitment (HC) and Limited Commitment (LC) individuals. For the Army, FC and LC individuals serve against the requirement whilst HC individuals fill posts specifically for FTRS personnel. For the RAF, FC individuals serve against the requirement whilst HC and LC individuals fill posts specifically for FTRS personnel. All Navy FTRS individuals serve against the requirement.

2. 1 April 2009 figures exclude: **1,450**^p Army Reservists mobilised for service of which
40^p are from the Regular, not Volunteer Reserves;
200^p RAF Reservists mobilised for service of which
- ^p are from the Regular, not Volunteer Reserves;
220^p Gibraltar Permanent Cadre
230^p Naval Activated Reservists of which
- ^p are from the Regular, not Volunteer Reserves.
None of these count towards the Trained Requirement.

3. 1 June 2009 figures exclude: **1,260**^p Army Reservists mobilised for service of which
40^p are from the Regular, not Volunteer Reserves;
180^p RAF Reservists mobilised for service of which
- ^p are from the Regular, not Volunteer Reserves;
230^p Gibraltar Permanent Cadre
220^p Naval Activated Reservists of which
- ^p are from the Regular, not Volunteer Reserves.
None of these count towards the Trained Requirement.

4. Due to ongoing validation of data from the Joint Personnel Administration System, Naval Service, Army and RAF strength statistics at 1 April 2009 and 1 June 2009 are provisional and subject to review.

5. Monthly requirements are Smooth Aggregate Liabilities (SAL) for each of the Services. These have been formed by interpolating between DP08 1 April 09 liability and DP09 1 April 10 liability for each of the Services. From 1 June 2009 Naval Service trained requirement includes additional FTRS that do not count against Regular Royal Navy liability and Army trained requirement includes FTRS(HC) liability.

Due to rounding methods used, totals may not always equal the sum of the parts. When rounding to the nearest 10, numbers ending in 5 have been rounded to the nearest multiple of 20 to prevent systematic bias.

p denotes provisional.
